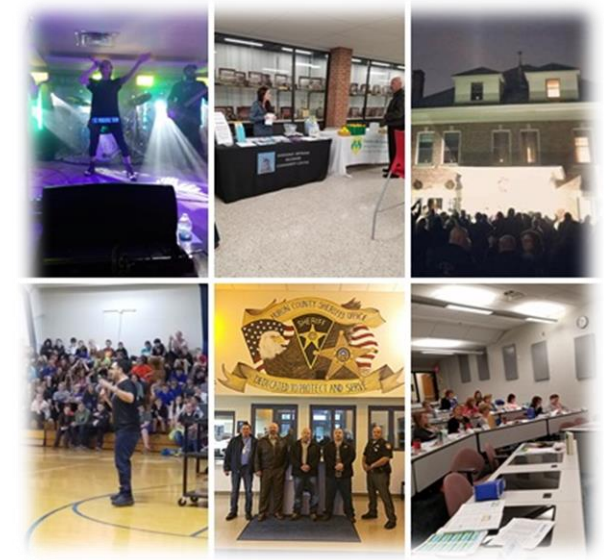

FY 2018 Report to the Community

FY 2018 has been a year of collaboration, new projects, improvement and growth for the Board's Continuum of Care. The summer brought a collaboration with NAMI of Huron County as we partnered to staff a booth at the Huron County Fair. What a great way to meet and greet our neighbors!

To help combat the problem with overdoses, the Board met with the Huron County Sheriff, Norwalk and Willard police, Firelands Counseling and Family Life Counseling to organize and develop a Quick Response Team (QRT). The QRT does weekly visits to those who overdosed, to offer support and services.

Partnering with the County Commissioners and other stakeholders, an educational event, **Death by Addiction – A Call to Action**, took place in October. Over 120 residents attended which resulted in various individuals stepping up to help with community needs. The following actions resulted:

- ✓ Rave 4 Recovery-a musical event for youth organized by the faith-based community, businesses and volunteers
- ✓ Collaboration to bring Drug Free Clubs of America to Norwalk schools in Fall of 2018
- ✓ Funding and volunteers to open the Huron County Peer Recovery Community Center under FI Community Housing

Various other planning activities are on-going and will continue into the new year.

Working with Starting Point Outreach in Willard, the Board approved funding for a five-bed men's recovery home, House of Hope. Huron County's Continuum of Care was further expanded by the addition of Family Life Counseling providing a Curriculum-Based Support Group program in the classroom for ages 5-12. Early Childhood Mental Health consultation provided by Bayshore Counseling Services was added for all pre-schools in the County. The PAX good-behavior training took place for 25 teachers in three school districts. PAX is a classroom-based preventive intervention that gives teachers the skills and strategies to create nurturing classroom environments by teaching self-regulation, co-regulation, and group regulation throughout their daily instruction.

Internally, the Board was awarded a one-year *Culture of Quality* certification. The *Culture of Quality* program was developed by the Ohio Association of County Behavioral Health Authorities and its member Boards to improve the quality of the statutorily mandated functions of county Boards administering local alcohol, drug addiction and mental health services for Ohioans.

Board members met for a two-day **Strategic Planning** session. The members demonstrated their commitment to working together to elevate and improve the behavioral health services available to Huron County residents.

Thanks to our MANY community partnerships, our mission is being actively achieved!

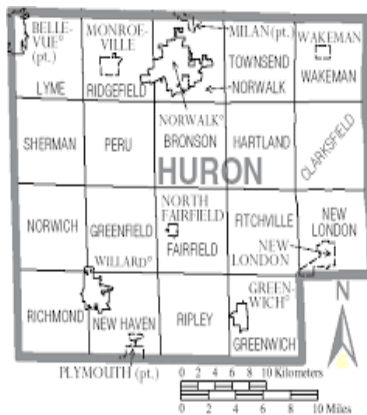
Our Values

In the spring of 2018, the Board released a **Request for Proposals**. Nine agencies applied with 14 proposals. The Board awarded SFY19 contracts to all nine agencies, adding additional treatment, prevention and recovery service options for Huron County residents.

We partner with:

- **Criminal Justice** to develop drug courts, Crisis Intervention Teams, guardianships, and treatment services to save lives, decrease recidivism, and to maintain a healthy community
- **Other Social Service Agencies** such as the Health Department, Children Services, and Family and Children First to leverage resources to better serve our families with integrated services
- **Schools** to incorporate prevention and wellness into the curriculum and to assist educators in understanding and dealing with challenging behaviors
- **Other Boards** to share resources and knowledge to maximize the return on taxpayer funding
- **Individuals and Families** to participate in planning, developing, and implementing services and supports in our community
- **With our Provider Network** to ensure high quality, accessible, evidenced-based services to meet our community needs



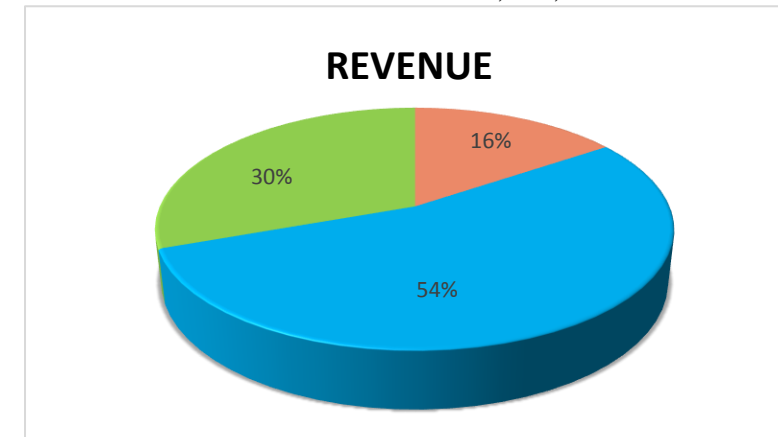
